OOA GIVES OSU MED STUDENTS TOOLS, SUPPORT AS THEY BEGIN SCHOOL

The OSU College of Osteopathic Medicine and the Oklahoma Osteopathic Association have a relationship that dates back to the school's founding 50 years ago.

“OOA was instrumental in getting the College of Osteopathic Medicine started, and many of our association's presidents, leaders and most accomplished members have been graduates of OSU-COM,” said OOA CEO and Executive Director Allison LeBoeuf. “It's a relationship we cherish and foster, supporting our medical students with resources and a community of physician mentors to encourage the next generation of OOA members and osteopathic physicians within our state.”

The OOA was founded in 1900 — before Oklahoma was even a state — as an affiliate of the American Osteopathic Association, and today it represents more than 2,000 D.O. physicians,

residents, interns and medical students in the state.

Each year, OOA supplies the incoming medical students with their white coats and OOA board members present students with their first stethoscope at an informal presentation and meet and greet during their first week of classes.

“It's amazing to see the spark of excitement in the students' eyes when they receive their stethoscope and shake the hands of the OOA board members handing it to them. We've received some lovely thank-you notes from the students, and it's nice to know that the contributions of OOA members that enable us to provide these stethoscopes and white coats to the incoming class have such a personal impact,” LeBoeuf said.

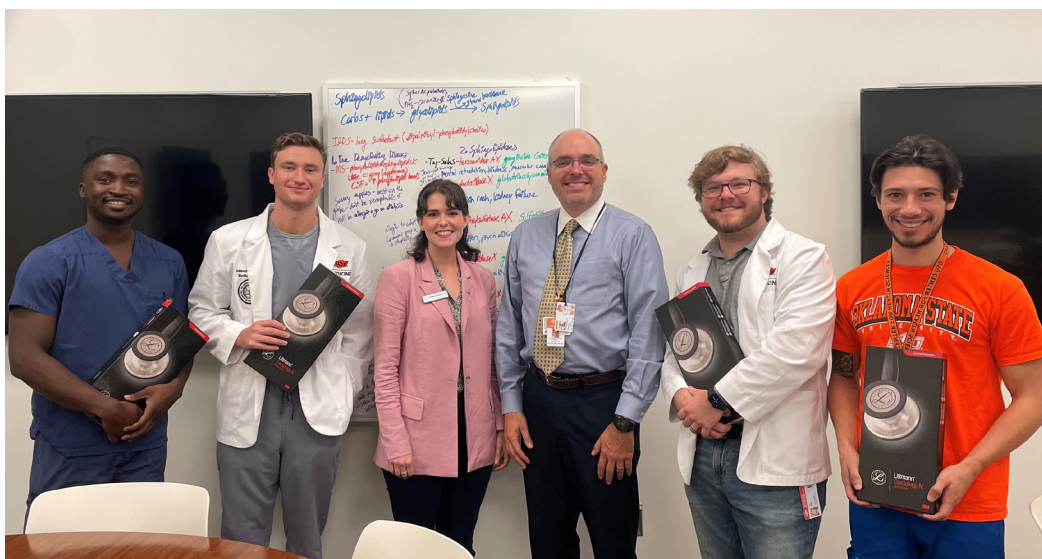
Dr. Natasha Bray, interim dean of OSU-COM at the Cherokee Nation, said OOA advocates for practicing physicians and supports medical students in order to ensure the future of the profession for Oklahoma and its citizens.

“Osteopathic physicians in Oklahoma support one another and our students. Students are the future of our profession, they will provide vital care to our families and communities,” Bray said. “OOA supports our students in very tangible ways by providing them with their first white coat and stethoscope as well as scholarships, but they also provide mentoring and education as our students develop their professional identity.”

LeBoeuf said the OOA board members and staff look forward to meeting the incoming class each year and talking about how they and the organization can best serve the students on their journey into the practice of medicine.

“We want to prepare each generation of OSU medical students with the proper tools to practice excellent medicine and show them how valued they are within our state as future Oklahoma physicians,” LeBoeuf said. “OSU-COM students, before they even begin their first day of classes, are important advocates for the health and well-being of their future patients and can be very effective in helping to shape the laws and regulations that will impact their future practice.”

OSU-CHS HOSTS NORTH HALL RIBBON CUTTING, CELEBRATES MED SCHOOL 50TH ANNIVERSARY

OSU Center for Health Sciences commemorated the opening of the campus' newest building North Hall with a ribbon-cutting ceremony, as well as celebrated the 50th anniversary of the OSU College of Osteopathic Medicine during an event Thursday, July 28, in the lobby of the new facility.

The 120,000-square-foot North Hall building is home to the new Office of the Chief Medical Examiner in Tulsa as well new anatomy and neuroanatomy labs, three classrooms, 65 graduate program student study carrels, 21 conference and meeting rooms and department and administrative office spaces.

"All of us are so very grateful for the culture we have in the Cowboy family, and part of that culture is not going at it alone. We believe in collaboration and partnership, and it's our valued partners who helped us get here today," said OSU-CHS President Johnny Stephens. "This building represents the growth both in our Physician Assistant program and in our graduate programs at OSU-CHS. New facilities like this help us attract and educate the state's best and brightest students and gives us room to grow in the future."

Working with state legislators including Sen. Roger Thompson and Rep. Kevin Wallace helped secure a portion of the funding for the facility that more than doubles the square

footage of the Medical Examiner's office in Tulsa and greatly increases the size of the anatomy lab and offers a dedicated neuroanatomy lab for medical, physician assistant and graduate program students.

"I appreciate my good friends at OSU and the Medical Examiner's office coming together to work on a plan for a space that meets the critical needs of such an important function of state government," Thompson said. "I also appreciate OSU's leadership in the health care realm in the state and am always very supportive of President Kayse Shrum and Dr. Stephens' vision. I have no doubt that many more great things are to come from this campus and am grateful for OSU's many prosperous partnerships with the State of Oklahoma."

Wallace recalled a few years ago when OSU and the Office of the Chief Medical Examiner brought forward a plan for a joint space that would not only meet the needs and accreditation requirements of the Medical Examiner's office, but would also allow more lab and educational space for OSU to continue training the state's next generation of doctors.

“It was easy to be supportive of the joint effort and I know I speak for my colleagues in the House of Representatives when I say we are appreciative of the collaboration among the two entities to make this state-of-the-art facility a reality for the state,” Wallace said.

Dr. Eric Pfeifer, chief medical examiner, said nestled in the heart of North Hall is an advanced and unparalleled facility.

“In my position, I’ve seen medical examiner’s offices across the country, and this one is without equal,” Pfeifer said, and the same could be said for OSU-CHS’ lab spaces. “What’s going to come out of this school will rock the medical world.”

The North Hall project started when Shrum was still president of OSU-CHS and dean of the medical school, and it’s just the latest example of collaboration and partnership, which has become a hallmark of the institution in its 50-year history.

“At OSU we are proud of the partnerships that we have forged with public, private and philanthropic entities across our great state,” Shrum said. “It’s also a wonderful day to mark the 50th anniversary of our College of Osteopathic Medicine and to consider the impact a facility like this will have on our mission of preparing the next generation of physicians and health care professionals to serve Oklahoma.”

Several notable alumni also attended the event and spoke of their ongoing relationship with the school including Dr. Trudy Milner, who graduated from OSU-COM in 1988 and now serves on the OSU/A&M Board of Regents.

“I started my journey to become a physician in 1984. I had been working as a nurse and had two young daughters, so I was not the typical medical student,” Milner said. “And while

the progress all around us at OSU-CHS is truly something to behold, I can tell you the quality of education goes back to day one at this medical school. I have always been so proud to call myself an alumna of OSU’s College of Osteopathic Medicine.”

Dr. Dennis Blankenship graduated from OSU-COM in 2001 and now serves as the interim dean of his alma mater.

“When I set out to be a physician, my dream was to return to my hometown and practice primary care. During my journey, I fell in love with emergency medicine and my path changed as I found a new passion in teaching,” Blankenship said. “I began training students and residents in emergency medicine and that continues to be one of the best parts of my job today. I’m so proud of our college and our students and graduates.”

Stephens said it’s hard to believe that it’s been 50 years since the college of established to train physicians for rural and underserved Oklahoma.

“I am proud to say we are fulfilling this mission every day with over 3,800 alumni and more than 800 doctors practicing across the state,” he said. “As we celebrate 50 years of our College of Osteopathic Medicine on our campus, we look forward to continuing our mission to educate primary care physicians for rural and underserved Oklahoma.”

NEW ANATOMY, NEUROANATOMY LABS MAJOR UPGRADE FOR STUDENTS AND FACULTY

As part of the new North Hall building on the OSU Center for Health Sciences campus, medical and graduate students now have access to new, modern anatomy and neuroanatomy labs that greatly expand the available space of the former lab.

“It’s at least three times as big,” said Thom Garrison, lab coordinator and director of the OSU Body Donor Program. “Everything was in the same space. Now we have an entryway with storage spaces for student belongings, dedicated wash stations, tables and chairs for study.”

And there is just more square footage in the lab itself.

“Students bumping elbows with students at the next table was fairly common in the old lab. Students have more space to move around and work on their assigned cadavers. We also have more storage space for equipment, skeletal and anatomical models,” Garrison said. “The cadaver storage unit is twice the capacity and is located in its own secured area of the lab.”

The neuroanatomy lab is also a major upgrade from the previous lab space, said Professor of Anatomy Kent Smith, Ph.D.

“In the past, all neuroanatomy courses were taught in the gross anatomy lab meaning multiple medical and graduate student courses all shared space, which was very challenging for students and faculty,” Smith said. “Now, like at our OSU College of Osteopathic Medicine at the Cherokee Nation campus in Tahlequah, there are two separate labs: one for gross anatomy where whole bodies will be studied and one for neuroanatomy where only brains will be studied.”

Smith said the neuroanatomy lab will accommodate new graduate courses in addition to the regular neuroanatomy courses that were offered in the past.

The additional lab space also allows room to grow with 16 stations now available in the gross anatomy lab, each with its own area for daily supply storage, dry erase board and countertop space for laptops or books.

This semester there are 13 stations being used in each of the three anatomy classes with students divided into groups of four at each station.

“The AV system is a welcomed upgrade— a two-camera system, bigger and better monitors and audio throughout the lab,” he said. “The new lighting is also a vast improvement. No more shadows over the cadaver, which makes for a much better dissection environment.”

There is also a dedicated temporal bone lab so students can study the area of the head where the ear is located using real bone and tissue, and not just rely on models, Garrison said.

The new lab spaces also honor those who made the decision to donate their or their family member’s body to the Body Donor Program.

“They are our honored guests and we’re privileged to have them here,” Garrison said.

Each group of students is assigned a donated body at the beginning of the semester, and they will dissect and learn from their cadaver during their time in the lab.

Clinical Assistant Professor of Anatomy Ian Browne, Ph.D., said that the assigned body is the students’ first patient.

“They’re probably the best anatomy professor they’ll ever have,” Browne said. “They were members of the community and they cared about the community. They gave this gift so our students could go out and care for the community.”

REQUIREMENTS

- Only one abstract will be allowed per individual. Multiple submissions from the same person will be automatically rejected.
- Length is not to exceed 250 words. The 250-word limit applies only to the body of the abstract. The limit does not include the list of authors and their respective institutions, nor does it include the title.
- Format:
 - Abstract should be double spaced and sent (in Microsoft Word.doc format) via email to mykayla@okosteo.org. Your email should include the following information:
 - Name
 - Research Title
 - Cell phone number
 - Email address
 - Mailing Address
 - Year of osteopathic or allopathic medicine school and school name
or year of postgraduate training, specialty and postgraduate institution.
 - The title needs to be centered and bold-faced.
 - Immediately under the title, list your name and year (OMS I, OMS II, PGY I, PGY II, etc.).
 - List authors and their respective institution(s). The student or physician who will present the poster must be listed as the first author. The principal investigator must be listed as the last author. Only the entrant is required to be a student or physician in training.
 - The body must include purpose of research and brief overview on method, result and conclusion.
 - No diagrams or tables should be included in the abstract.
 - Do not include references.
 - Your abstract can be about previously reported or current results. If your abstract has been previously accepted and/or presented at other conferences and/or published, please provide the following relevant information (this information will not be considered as part of the 250-word limit):
 - Conference name
 - Conference location
 - Date
 - Format or journal name
 - Journal volume
 - Journal edition
 - Journal date
 - Page numbers

Abstracts that do not meet the requirements stated above will need to be reformatted before acceptance. Individuals whose abstracts are accepted will be notified via email.

CRITERIA FOR EVALUATING ABSTRACTS

The judging panel will be evaluating the abstracts submitted based on the following criteria:

- Statement of the hypothesis.
- Clear organization of the project.
- Effective use of the scientific method is evident.
- All significant variables have been identified. Efforts to eliminate bias between control and experimental groups are clear.
- The conclusion is consistent with the data and/or observations.
- Potential pitfalls of methodology or interpretation have been addressed.
- The potential significance of the experiments is placed in the proper perspective.
- Abstract is in required form and organized, well written, concise, and readable.
- The project demonstrates a novel approach and/or idea.

POSTERS

Research posters must be received in digital format by 5 p.m. on Friday, November 11, 2022. Please send digital posters to mykayla@okosteo.org.

REQUIREMENTS

- Submit digital posters in the form of a PowerPoint slide (no animations), high resolution JPEG or PDF via email by the submission deadline.
- By submitting a poster to the OOA Research Poster Symposium, you certify that the poster is your original work or—if original work conducted by you and another author—any co-authors are appropriately credited for their contribution and have been informed of the submission. Infringements will result in disqualification from the symposium.
- Any research involving human research subjects must attach a copy of IRB approval with your abstract.
- Posters should be free of commercial bias, product endorsement or marketing.

CRITERIA FOR EVALUATION

- Research posters will be judged to include the following key components:
- Clear statement of a research question
- Abstract
- Evidence to support research
- Explanation of methodology
- Graphic materials to illustrate results, such as a table or graph
- Significance of findings
- Cited references

The judging panel will judge each poster individually using the following objectives:

- Is there a clear statement of research question or relationship being investigated?
- Does the poster require additional explanation? Does it stand alone?
- Is there a logical and thorough explanation of the research question?
- Are all components of the research given appropriate levels of attention?
- Is there adequate consultation of sources cited correctly?

- Was an appropriate research methodology selected and explained effectively?

Quality of Evidence

Relevance

- Is the research presented relevant to osteopathic physicians today?

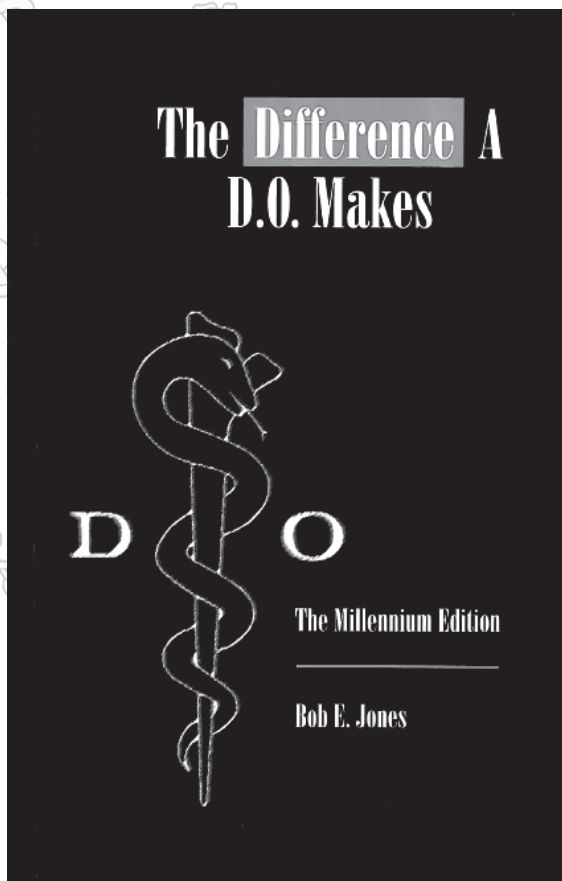

In Memorium



Ebb Willis Reeves, DO, 91, of Tulsa, OK, passed away on August 22. Kind, generous, brilliant, pragmatic, thoughtful, gracious, witty, humble, loyal, a leader, a mentor, a healer, a friend, a father, a romantic - just some of the many words that come to mind when those who know him think about Ebb. He

was also the king of the slightly off-color dad joke or humorous rewrite of traditional song lyrics to entertain his kids and grandkids.

Following graduation from the University of Texas at Austin in 1952, Ebb was a pharmacist at his family-owned drug store in Denton, TX – Reeves Drug. After a 24-month stint in the U.S. Army he returned to Denton, where he and his wife, Barbara Wheelless Reeves, had three children. He continued his pharmacy career while attending medical school at the Kansas City College of Osteopathy and Surgery. Ebb graduated second in his class and expanded his family with one more child before moving to Tulsa, a city he would call home and where he would build his professional life for most of the rest of his time on earth.

Ebb was not in Tulsa long when he lost his wife, Barbara, to encephalitis. He continued to raise his four children as a single working dad, with much help from his family, friends and his new Tulsa community. In 1970 he married Norma Kay Thompson Swank and added another beloved daughter and sister to this now family of seven.

A well-respected and beloved family practice physician in Tulsa for decades, Dr. Reeves delivered more than 2000 babies and cared for multiple generations of families. He was active in his professional associations, serving as the president of the Oklahoma Osteopathic Association and as a lifetime member of the American Osteopathic Association. He also led the medical team at the Oklahoma Osteopathic Hospital (now the OSU Medical Center) as the Chief of Staff in 1977-78. Over the life of his career, he held many other leadership positions,

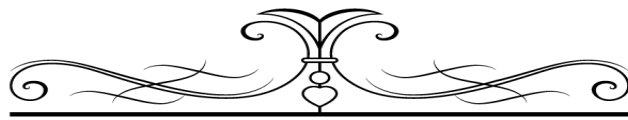
including as Chairman of the Osteopathic Hospital Founders Association, Chairman of the Board of Trustees of the University of Health Sciences College of Osteopathic Medicine in Kansas City, Trustee of the Oklahoma State University Medical Center Trust and many more.

He was frequently honored for his service and dedication to the medical profession and to his community. Dr. Reeves was named the Outstanding Physician at the Oklahoma Osteopathic Hospital in 1990, received the Distinguished Public Service Award from the Oklahoma State College of Osteopathic Medicine in 1990 and the Doctor of the Decades Award from the Oklahoma Osteopathic Association in 2011. Also in 2011, he was named an ICON for Oklahoma State University for his service to the school and the integral role he played in connecting the osteopathic college as a vital addition to the university.

He moved from Tulsa to St. Louis where he was an administrator for the Deaconess Medical Center until his retirement in 1996. He lived out his retirement years in Tulsa, where he continued to act as a surveyor of internships and training programs for the American Osteopathic Association and to serve on the Credentialing Subcommittee for Blue Cross & Blue Shield of Oklahoma.

Throughout his career, he considered it an honor and a privilege to help educate and support medical students as a teacher, a mentor and a professional guide. In fact, his final wish was that his body be donated for scientific use at an osteopathic college so students can perfect and better their craft and to pay it forward for a profession that had served him well.

Ebb Reeves is survived by his beloved wife, Kay, and his five children: Pamela Reeves Thomas; David Reeves and his wife, Cindy; John Reeves and his wife Heather; Ellen Swank; and Sally Reeves Ray and her husband Bill. He was also a beloved Papa to 15 grandchildren and GG-Pa to four great-grandchildren. He is also survived by his sister, Anna Reeves Holzer, and her three sons, his sister-in-law, Mona Whitmire and her husband Mark, as well as her two children and many other nieces, nephews, great-nieces and great-nephews.

He graduated from Kansas City University of Medicine and Biosciences in 1960.

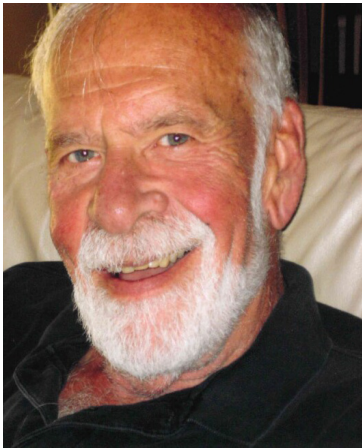
